LOEB HOUSE INN HOLIDAY OPEN HOUSE

The Italianate style home located at 708 Cincinnati Street was built in 1882 by Emerson P. Knight and later sold to Solomon and Carrie Loeb in 1895. The Loeb's lived in the home for over fifty years and then the house was sold and divided into six apartments. In 1995 the house was restored to its original floor plan and style and is known today as the Loeb House Inn Bed and Breakfast owned by Dick Nagel. Dick and WVT teamed up December 30th to host a holiday open house. Trees and historic ornaments adorned each room and offered a beautiful setting for visi-

tors, many of whom stayed to enjoy refreshments provided by WVT. The newly opened Tea Room was a popular spot for guests to visit and enjoy the afternoon. The Tea Room is run by Sue Rosenberger and is open Thursday, Friday, and Saturday between 11 am and 4 pm. Plan to stop by for an afternoon of tea and treats in one of our community's historic homes.

IVH UPDATE

Planning a charrette and stabilizing the buildings are two activities that took place during the first year of owning the Administration Building, Lawrie Library, Men's Dorm, and Commandant's House at the Indiana Veterans Home. Through a \$15,000 grant from the Efroymson Foundation, roof and foundation work are currently taking place at the Lawrie while the Men's Dorm has seen roof and stabilization work. The IVH Steering Committee is meeting regularly and is developing plans for a charrette in the fall. This 'brainstorming' exercise will help WVT make informed decisions on the use and sustainability of the four buildings.

"BUILDING KNOWLEDGE" WORKSHOP

In October WVT received a grant from the Indiana Humanities Council to update and reprint our publication, Researching Your Historic Building. Along with making this guide available to the community, the Trust will offer a workshop titled "Building Knowledge" to neighborhood associations and community organizations with the goal of inspiring owners of historic buildings to learn about their properties, their historical significance, and the people who built and lived in them. 
